**Subject: Clarification regarding admissibility of special concessions in Kasmir Valley to KVS employees, Reg.**


Madam/Sir,

With reference to the subject cited above, it is informed that initially sanction of chairman, KVS, was conveyed vide KVSHQ letter dated 07.07.1994 for grant of special concessions /facilities, viz (i) Transfer grant, (ii) House Rent allowance & (iii) Cash Assistance to KVS employees. Subsequently, vide letter dated 09.09.2010 of this office a clarification on the issue was issued including terms and conditions for admissibility of messing allowance.

However, of late we are receiving a lot of RTIs and queries as regard to admissibility of cash assistance and messing allowance, in view of audit objections. It was felt to re-visit the matter and answer the frequently asked questions (FAQs) categorically as appended below.

Sl.N	FAQ	Answer
01	Package of special concession/ facilities to central Govt. employees working in Kashmir Valley has been extended to KVS employees or not?	Yes, such concessions were extended to the KVS employees to the extent as detailed above only to those who have shifted/ not shifted their families from the Kashmir Valley during the period 1 <sup>st</sup> May 1990 to 30 June 1994.
02	Who are eligible for drawl of cash assistance (per diem allowance)?	Cash assistance @ Rs.10/- per attendance day has been granted to the KVS employees who have not shifted their family from Kashmir valley during the period 1 <sup>st</sup> May 1990 to 30 June 1994.
03	Who are eligible for drawl of Messing allowance?	Messing allowance is admissible at a uniform rate of Rs.15/- per day to KVS employees who have not shifted their family from Kashmir valley during the period 1 <sup>st</sup> May 1990 to 30 June 1994.
04	Is facility of messing allowance and per diem allowance admissible to the natives of Kashmir Valley also ?	The facility of messing allowance and per diem allowance shall also be allowed to natives of Kashmir Valley in terms of Kashmir valley package.
