Madam/Sir,

I am to refer the above cited subject & reference regarding the Admission of wards of Kashmiri migrants in Kendriya Vidyalayas. Similar to preceding years Government of India, Ministry of HRD has extended the concession in admission in Kendriya Vidyalayas for the wards of Kashmiri Migrants till further orders. Accordingly the KVS has extended the following concessions in admission matters.

- I. Extension of date of admission by 30 days.
- II. Relaxation in cut -off percentage, so as to be equal to that applicable for SC/ST students subject to minimum eligibility requirement.
- III. Admission to be over and above the class strength.

The Vidyalaya should ensure verification of the documents in support of Migration from Kashmir Valley before admission is given.

You are requested to comply with the above instructions.
